In 2019, Jeff Robbins was appointed by Colorado Governor Jared Polis as the Director of the Colorado Oil and Gas Commission (COGCC), the regulatory body overseeing oil and gas development within the state. Robbins was the lead negotiator and drafter of SB 19-181, the law that fundamentally transformed the regulation of oil and gas in Colorado. As Director, Robbins oversaw and led the Commission's implementation of this landmark legislation that changed the COGCC's mission from "fostering" oil and gas development to "regulating" in a manner that is protective of public health, safety, welfare, wildlife and the environment.

In July 2020, when the Commission moved from a volunteer board to full time, Robbins was appointed the first Chair of the Commission. As Chair, Robbins continued leading the implementation of the SB 19-181 protective framework and, as a result, has re-imagined the regulatory environment. In recent years, as Chair, Robbins drafted and successfully guided additional legislation and is currently implementing new statutory directives to the Commission that: provided regulatory authority over emerging energy technologies necessary for Colorado's clean energy future; and reimagined protective financial assurances for the energy industry.

Prior to his governmental work, for over 25 years, Robbins had a private law practice based in Durango, creating strong relationships with local industry and environmental NGOs.
